Leaving a **Balance of \$000.00** to be paid by May 24th I have agreed to transport the puppy to him leaving Tulsa June 7th for a extra **\$000.00** which will need to be paid by the morning of the day of transport.

1. To the best of my knowledge, said puppy/dog is in healthy and sound condition at the time of sale. Buyer has 72 hours from the time of delivery/pickup to have a vet check done on said puppy. Vet check must be done by a licensed veterinarian. Buyer is required to have the veterinarian administer two or more puppy vaccines on said puppy, parvo and distemper vaccines must be given at two-four-week intervals following first vaccines given by breeder. If buyer fails to have vet check done within 72 hours or fails to continue vaccines with a veterinarian as stated above, the parties agree that any guarantee will be considered ***null and void***. Keep the shot records from your vet.
2. Buyer understands that it is not recommended for puppy to visit dog parks, pet stores or any populated or traveled areas until said puppy is fully vaccinated by a licensed veterinarian (approximately 16 weeks). _____
3. Seller requires that buyers partake in proper socialization and basic training with their puppy. This greatly influences the long-term relationship between you and your puppy. Puppy shall not be subject to taunting, teasing or abusive handling. Should the seller at any time find out the puppy/ adult is mistreated, neglected, and/ or abused by buyer or anyone in the buyer's household; The seller reserves the right to remove puppy/adult from buyer and assume immediate and legal possession. There will be no reimbursement to the buyer. Buyer may be held accountable to criminal charges. _____
4. All puppy /dogs sold as **PET QUALITY** only, this does not mean that they are, or are not show breed quality. As a breeder, I strive to meet the breed standard. However, one's interpretation of show/breed quality may be different from another's.
5. Puppy/adult has been sold on **PET REGISTRATION**.

A. If you are buying a male with the intention to breed; I do not guarantee him to have viable semen. I do not guarantee him to actually breed. If you buy a puppy that needs to be

shipped, my vet will make sure both testicles are there (they may not be completely dropped at 8 weeks). If he is an adult, we will make sure both testicles are descended before he leaves

B. Health guarantee is null and void if puppy/adult is bred before 2 years of age.

C. There is no warranty against bad bites. If requested I can have a vet note a scissor/correct bite before the puppy leaves. After the puppy leaves, a change in bite is not covered and the dog will not be replaced.

Health guarantee does not cover any parasite, internal or external as this is a treatable condition. Only untreatable, genetic diseases or defects will be considered. Each case is dealt with individually. Health guarantee covers congenital health defects such as heart, lung, liver and kidney disease.

Puppy is guaranteed for up to two years from whelping date against any crippling hip dysplasia or genetic disability. _____ "

Due to the varying kinds of food and different environmental conditions the puppies come in contact with; and the fact that all puppies have immune systems that take time to mature, we highly recommend immune system builder to help them maintain optimal health. We are so confident NuVet Plus will benefit your new puppy; we will extend this two-year guarantee to the lifetime of the dog. To qualify for this extended health guarantee, you must give your new puppy NuVet Plus with my code 53840. using the manufacturer's recommended daily dosage, for the entire guarantee period. Failure to do so makes this guarantee extension null and void." We also highly recommend you continue to give your pet NuVet Plus beyond the guarantee period to promote optimal health for a lifetime. _____

6. In the unfortunate event that your puppy/adult is to be returned and replaced under the health guarantee; the buyer understands that there will be no replacements for a dog that has been bred or altered. _____

If the puppy/ adult is replaced under the health guarantee that it will be a ONE-TIME replacement. Once replaced, buyer understands that breeder assumes no further responsibility and is no longer liable for any reason. _____

7. If for any reason Buyer cannot care for puppy/dog, he/she agrees to offer the puppy back to Seller and she will then help rehome puppy/dog. Please never feel like you have to place a puppy in a shelter. I am here to help you 24/7 with any of your puppy/adult dog needs. I do not guarantee the size of puppy. I can only take an educated guess as to how big or small the puppy might be when the puppy reaches maturity.
8. Puppy is required to be paid for in full by 7 weeks of age. If a payment plan has not been arranged and the puppy is not paid for in full by 10 weeks, puppy is subject to being relisted and sold to someone else. * *With communication we may be able to transfer your deposit to a different puppy.* * _____
9. If puppy is not picked up by 10 weeks of age, puppy will start to accrue boarding fees of \$10 a day. _____ If said puppy has not been picked up, any veterinary expenses accrued after 8 weeks of age is the responsibility of the buyer. This includes but is not limited to, the second 5-way combo vaccine due at 9 weeks of age. _____

10. If for some reason something were to happen to the puppy while in the care of ONLY Primitive Rose Aussies until the delivery date (natural death or accident) I, Mindie Robertson from Primitive Rose Aussies will allow you the Buyer to have a replacement puppy of equal value. **Meaning same sex, same color, same size. You my customer will be taken care of to the best of my ability. No cash refund, only a replacement puppy of equal value or credit towards another puppy of choice within one year of date on contract. AGAIN, this is only in the event of natural death or accident.
11. As the Seller, I understand that the typical puppy buyer is not necessarily as experienced with raising puppies as I am. If there is any concern at any time with your puppy, please call right away for tips and advice. Sometimes I can save an unnecessary trip to the vet. 12. Seller is in no way responsible for any vet bills made after puppy/dog leaves the care of Primitive Rose Aussies. In the event that a problem should arise with said puppy, Buyer should contact the Seller immediately. Each case is dealt with individually as every situation is different. Seller will not refund money in any situation. Shipping is always the responsibility of the Buyer, even in the event a puppy is to be sent back and/or replaced. All vet bills are the responsibility of the Buyer. NO exceptions. All shipping costs related to any dog being purchased, as well as in a relationship to any dog being replaced for any reason, are the responsibility of the Buyer.
13. Seller shall not be responsible for the death of said puppy/dog due to negligence or carelessness of any airline or other live animal carrier, it's agents or employees, or the Buyer.
14. I can/will help arrange shipping; however, the buyer must pay shipper directly
15. I have my kennel name registered with ASDR and my kennel name Primitive Rose will proceed the name you give your puppy,

This contract is under the jurisdiction of the State of Oklahoma. In the event of any dispute, the parties mutually agree that the dispute will be settled under the jurisdiction of Tulsa County, Oklahoma. All parties agree that all lawyer fees will be paid for by the Buyer. This agreement sets forth the entire agreement between both parties. This agreement may not be changed, altered or amended except in a writing signed by both parties.
